The charts above should assist you in determining the amount of loans you will need to borrow for Summer 2020. Please use the chart that reflects your entry into Charleston School of Law. The first column, entitled "Number of Credit Hours," is a list of the number of hours you are taking over Summer 2020. The second column, entitled "Tuition Costs," is the amount of tuition costs that will appear on your Charleston School of Law ledger. The third column is entitled "Maymester (M1) & Summer (SS, S1, E1) Max Loan Eligibility." If you are taking classes in both Maymester and Summer (SS, S1, E1) sessions at Charleston School of Law, please use this column (3). The fourth column is entitled Only Summer (S1) and/or Externship (E1). Please use this column if you are taking classes in Summer (S1, E1) session, and not in Maymester or Summer Standard.

Remember:

Students must be in at least 7 hours to be aid eligible for Summer 2020. The 7 hours may include Maymester. Independent Study courses are not eligible to determine eligibility. The figures in the chart are only applicable at Charleston School of Law.
